Taxes from one or more prior levies on your account are unpaid. To determine the unpaid amount please call (914) 722-1170 at your earliest convenience. Continued failure to pay all levied taxes will result in loss of your property.

INFORMATION FOR STATEMENT OF TAXES

1. Make checks payable as indicated on front of statement. DO NOT POST DATE YOUR CHECK.
2. Record your bill number on your check.
3. Return the remittance portion of this statement with your payment in enclosed address.
Payment Address: Town of Scarsdale, P.O. Box 1980, Binghamton, NY 13902.
4. Payment may be made in person at Village of Scarsdale Village Hall Tax Office located at 1101 Post Road, Scarsdale, NY 10583 Monday through Friday 9 am - 4 pm or by utilizing the drop box outside of the building. Please note, the drop box outside of Village Hall will close at 5 pm on the last day of the collection period.
5. Payment can also be made online at Scarsdale.gov. This is in the form of a direct debit through your checking account. This is a secure site and we do not charge a fee.
6. Payments may be made within dates listed on the face of the bill without penalty.
7. Late payments will be subject to the following penalty schedule:

Please contact the Treasurer's Office (914) 722-1170 with any questions.

Property owners 65 years of age and older MAY be eligible for exemption on their PRIMARY RESIDENCE. Application deadline is MAY 1 (application, proof of age and income must be provided). Please go to www.scarsdale.gov for detailed instructions and the application.

REMINDER: New York State Law provides that a municipality cannot waive /penalties on real estate tax payments received after the due date for any reason. To avoid any possibility of delay by mail, we suggest that if payment of taxes is to be made within the last few days of the month in which due, make certain that it is either hand delivered to the tax office or that you witness a timely official United States postmark being affixed to the envelope. Pitney-Bowes and foreign postmarks are not acceptable.

The Town acts as collecting agent only for County and School Taxes. Questions regarding these taxes should be directed to either the County of Westchester or the Scarsdale Board of Education.
