

How to Pay Taxes



Payments can be made online using a checking account. Visit the Online Payments section of Scarsdale.gov. Credit cards cannot be accepted.



Checks can be placed in the Village Hall Mail Drop (to the right of the entrance to the Village Hall). The box will be locked at 5 PM on the last day of collection.

Checks can be dropped off at the Treasury Window on the first floor of the Village Hall. Cash is accepted in exact change only.

Payments are considered on time if postmarked on or by the due date. When banks mail checks, the envelopes are not usually postmarked.

County Tax

The County Tax is Billed on April 1st. A single payment is due by April 30th. Checks should be made payable to **The Town of Scarsdale.**

Village Tax

The Village Tax is billed on July 1st. The two installments are due by August 1st and December 31st. Taxpayers have the option to pay the ENTIRE amount by August 1st. The second installment can be paid any time up until December 31st. Checks should be made payable to **The Village of Scarsdale.**

Scarsdale Tax Payment Schedule

Taxes	Entire Amount/ 1st Installment	2nd Installment

Village	August 1st	December 31st
School	September 30th	January 31st

Pro Taxpayer Tip:

Put recurring reminders in your electronic calendars for lien and payment due dates. These dates are the same every year.

School Tax

The School Tax is billed on September 1st. The two installments are due by September 30th and January 31st. Taxpayers have the option to pay the ENTIRE amount by September 30th. The second installment can be paid any time up until January 31st. Checks should be made payable to **The Town of Scarsdale.**
